Options available to exhibitors are:

Request a Block: Companies requesting six (6) or more rooms have the ability to submit a request for a block of rooms.

Exhibitor: Companies requesting less than six (6) rooms will need to submit individual room requests.

Please make note of the move-in schedule below when reserving your rooms. Move in will begin Saturday, 1 June.

Move-in:

Saturday, 1 June 0900 to 1700 - All booths

Sunday, 2 June 0900 to 1700 - All booths

Monday, 3 June 0900 to 1700 - All booths

Move-out:

Thursday, 6 June 1500 to 2100

Friday, 7 June 0800 to 1700

All exhibits must be fully installed by **1700 on Monday, 3 June**.

These companies don't deliver what they promise and generally leave exhibitors with either substandard or no rooms and no ability for remedies or refunds. In order to avoid being taken advantage of please bear the following in mind:

- These companies have no connection with IMS or any MTT-S IEEE events.
- Please be cautious when responding to unknown sources claiming to be an "official housing company". **onPeak, the official company that coordinates IMS housing, does not do outbound solicitation for rooms.**
- The safest approach is to not book with anyone other than the "**Official**" IMS Housing Bureau accessed through the IMS website. However, under any circumstance use due diligence when doing business with any solicitor.
